#### CYBER CRIME TARGETS MORE AND MORE HNWIS

- HNWIs and Family Offices, Prime Targets
  - Approximately 38% of HNWIs and family offices lack a cyber security plan, significantly raising their risk of being targeted by cyber criminals.
  - Alarmingly, 32% of family offices have reported such financial losses.
  - Also, children of HNWIs are targeted due to their family's wealth and status.
- Specific Cyber Threats to HNWIs
  - *Ransomware:* HNWIs often face random demands far exceeding the \$570,000 average.
  - *Identity theft:* HNWIs are three times more likely to be victims of identity theft due to their high-profile status and extensive digital footprint.
- Reputation and Psychological Impact
  - *Reputation damage*: Nearly 40% of HNWIs affected by cyber crime report significant damage to their personal and professional reputations, underscoring the importance of comprehensive cyber security measures.
  - *Stress and anxiety:* Cyber crime incidents have led to increased stress and anxiety among HNWIs, with 65% expressing concerns about their personal and financial security.
